# The location: Villa Gernetto

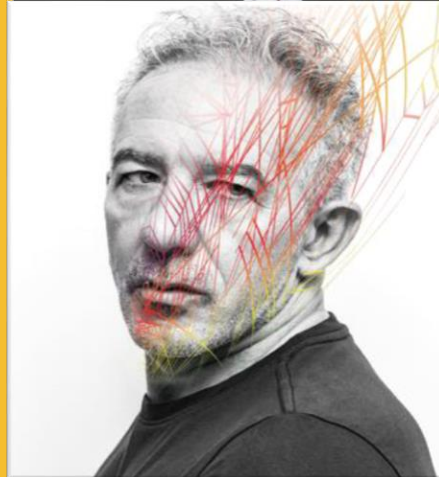
